

## Finnfund privacy policy

This privacy policy explains what is meant by personal data that Finnfund collects from you, with which purpose, how it is managed and with whom it is shared with.

### What is personal data?

“Personal data” is data that can identify you as a person. Personal data can be data used to directly identify a person (such as name, identification number and address) or indirectly (IP addresses, cookie ID, etc).

### Legal framework

This privacy policy is subject, amongst others, to the following privacy legislation (“Legal Framework”):

- Finnish Data Protection Act (1050/2018) on the protection of privacy in relation to the processing of personal data.
- regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (“GDPR”).

### Purpose of data processing

Finnfund can process your data in accordance with the Legal Framework described above and this privacy policy to exercise its activities and for the purpose of e.g. management, administration, and improvement of services. For instance, we may use your data for the following purposes to:

- respond to and follow up on your potential query.
- evaluate our participation in a potential transaction.
- provide direct marketing regarding our activities (such as updates, newsletters, emails, invitations to events and brochures).
- execute and assess contracts that have been agreed with your legal entity.
- store your job application and CV for the purpose of considering you for future recruitment, if you have offered yourself as a candidate for future or current recruitment.

### Retention

Finnfund only stores your data for as long as is necessary to achieve the purpose or further processing. The retention time will depend on the duration of the project or precontractual and/or contractual relationship with us. The data provided for the purposes of recruitment will be retained for three years.

## Your rights

As the owner of the personal data, you may exercise the following rights under the Legal Framework:

- Right to request access to your personal data.
- Right to request their rectification and erasure.
- Right to restrict their processing.
- Right to object to their processing.
- Right to data portability.
- Right not to be subject to a decision based solely on automated processing
- Right to withdraw your consent pursuant to which we are allowed to process your personal data.

## Security

Finnfund commits to take all reasonable technical and organizational measures to its best ability to safeguard the protection of the personal data against the loss, misuse, unauthorized access to or theft of their data.

The personal data is stored by Finnfund, or, if applicable, by the personal data processor. You acknowledge and accept that the transfer and storage of personal data is never without risk and consequently, Finnfund cannot be held liable for the damages that you may suffer as a result of the unlawful use of your personal data by third parties.

## Cookies

Cookies are alphanumeric identifiers placed on your computer to collect standard Internet log information and visitor behaviour information. When you visit our website, we may collect information from you automatically through cookies or similar technology.

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
